Thank you for your request for information received on 9 September 2022 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested below. The Trust would apologise for the delay in the provision of a response.

Question 1

Please list all grades of staff, their roles and job titles within NIAS who have received the Queen's Platinum Jubilee Medal.

Answer 1

The Queen's Platinum Jubilee Medal was received by Paramedics and EMTs who requested it. This includes Paramedics and EMT staff who operate on a contractual basis within the A&E tier of operations. However, there are other staff within the Trust who hold these qualifications and whose primary role is not within A&E, eg. Control, Training etc but continue to provide A&E cover on an overtime basis etc. Some of these staff operate in roles which, if listed here, could lead to the identification of the individual. As the receipt of the Queen's Platinum Jubilee Medal was a personal choice, the Trust does not feel it appropriate to provide this specific information.

I hope providing you with the information provided above in terms of staff roles this information will assist you. If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter.
