Thank you for your request for information received on 10 January 2022 which was dealt with under the terms of the Freedom of Information Act 2000. The Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested in relation to the below question and would respond as follow.

## **Question 1**

The number of times an ambulance has attended 8-10 Lake Glen Avenue, Belfast, BT11 8FE for each year since April 2014.

## Answer 1

The data analytics department have run a search of all emergency 999 calls answered via the Trust's Command and Control system and based solely on a resource arriving at scene for the period April 2014 to February 2021, a total of 161 emergency calls were answered which resulted in NIAS attending the above location.

The figure of 161 has been broken down by year:
