Thank you for your request for information received on 21 May 2022 which was dealt with under the terms of the Freedom of Information Act 2000. The Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested in relation to the below question and would respond as follow.

Question 1

When do you next expect to recruit for emergency ambulance control officers?

Answer 1

No planned recruitment for the next 12 months due to current active waiting list.

Question 2

What qualifications are required for such posts?

Answer 2

See attached Job description.

Question 3

What shift patterns do control officers work?

Answer 3

A range of shifts covering the 24 hour period to include weekends, night etc. All staff being employed into the Control Officer role are expected to be able to work all range of shifts. A new starter Control Officer will start within the relief tier.

Question 4

How is it decided which desk control officers work on each shift?

Answer 4

All Control Officers are expected to cover all desks on a rotational basis, the aim is for this to be evenly distributed over each area.
