Subject: Ambulance Response time to Killymoon Golf Club

Thank you for your request for information received on 27th September 2024 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below. The Trust would apologise for the delay in the provision of a response.

Question

I would need to know “the current response time” from the Ambulance Service to get to the Killymoon Golf Club (BT80 8TW) using the current entrance on Killymoon Road from its nearest station.

Answer

The response time from the nearest ambulance station which is Cookstown is 4 mins. Should the Cookstown ambulance crew be unavailable, support will be requested from the following stations:

Dungannon – 13 mins
Magherafelt – 21 mins
Omagh – 30 mins

It should be noted though that response times can be impacted by a range of factors including:

- Time of day
- Roadworks / road closures
- Weather conditions.

The response times also assume that crews are responding from station however this is often not the case. Crews can respond from hospitals; from other call locations if they clear on scene or on returning to station from having previously attended a call or cleared from the hospital.

I hope the above fully assists you.
