**FREEDOM OF INFORMATION REQUEST**

Thank you for your request for information received on 26<sup>th</sup> September 2024 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below. The Trust would apologise for the delay in the provision of a response.

**Question**

Quarterly or monthly data (or biannual/annual if more detailed breakdowns exceed the cost limit) on the number of ambulance callouts to suspected overdose events over the past three years, ideally up to the date for which data is most recently available.

**Answer**

Please refer to the attached document entitled Summary FOI 33632-24. Please note the figures have been provided based on criteria of 'overdose/poisoning/od', the figures do not include 'alcohol only' calls. Please also note that this is based on information provided at the time of the 999 call and therefore should be used in a discretionary manner.

I hope the above fully assists you.

Please note that, under the Re-use of Public Sector Information Regulations, if you wish to publish or otherwise use this information besides for your own means, you will need to seek our permission to do so.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter.
