Thank you for your request for information received on 20th August 2024 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below.

FOI QUESTION(S)	ANSWER(S)
How many ambulance callouts to Amazon warehouses across Northern Ireland have there been between 2019 and the present day? Please break this down by centre but NOT by year.	01/01/2020 to 22/08/2024 = 13
How many ambulance callouts to Tesco warehouses across Northern Ireland have there been between 2019 and the present day? Please break this down by centre but NOT by year.	01/01/2020 to 22/08/2024 = 11

I hope the above fully assists you.

Figures have not been broken down by centre, as numbers fewer than five could lead to the identification of individuals, compromising confidentiality in line with Section 40 of the FOIA and UK GDPR.

Please note that, under the Re-use of Public Sector Information Regulations, if you wish to publish or otherwise use this information besides for your own means, you will need to seek our permission to do so.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter.

If following an internal review, carried out by an independent decision maker, you remain dissatisfied in any way with the handling of the request, you may make a complaint under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the Trust has complied with the terms of the Freedom of Information Act.
