“This data has been sourced by using the reported “key complaint” category determined when a caller contacts the service; they do not necessarily reflect the correct number of patients with a definitive diagnosis of cardiac arrest / myocardial infarction / CVA e.g. myocardial infarction figures will contain many patients who present with symptoms of chest pain but are not subsequently diagnosed with a myocardial infarction.
