Response 4

Value for money is a subjective term with a number of definitions. However, Private/Independent ambulance contractors are engaged through a regional framework contract derived from a competitive tendering process administered by the Business Services Organisation (BSO) Procurement and Logistics Service (PaLS). Suppliers are engaged on the basis of a call off protocol that considers geographical area and lowest cost provider on the framework.

Question 5

How many vehicles they provided, for NEAC and EAC?

Response 5

Please see attached file IAS Numbers for FOI June 2023 which provides an estimate of the average number of IAS used each month taken from snap shot counts over three years of EAC and NEAC IAS numbers. It indicates a monthly average of 873 IAS crews utilised each month for the last three years. This is an approximate figure as this information is not routinely collected in an easily summarised form due to the manual nature of IAS provision.

Question 6

What was the skill mix of staff on those vehicles provided to cover NEAC and EAC? **Response 6**

The IAS procurement framework currently lists the following as suitable qualifications for IAS ambulance crews and thus illustrates the skill mix on IAS ambulances:

The Contractor's drivers and attendants must be fully trained and be able to maintain their competency to a standard that would be equivalent to that of NIAS Ambulance Care Attendants, who are trained to Edexcel Business and Technology Education Council (BTEC) Level 2 First Person On Scene (FPOS) Award or First Responder Emergency Care (FREC) 3 or equivalent to the current NIAS ambulance care attendant training throughout the period of the Contract. This includes training in first aid level, which includes:

- a) Basic Life Support with Bag-Valve-Mask (BVM) including Adult & Child cardiopulmonary resuscitation (CPR)
- b) Defibrillation using an automated defibrillator
- c) Airway Management & Oxygen therapy
- d) Patient Assessment
- e) Moving and handling including the moving of bariatric patients
- f) Infection and Prevention Control
- g) Treatment of patients with infectious diseases and conditions
- h) Equality and Diversity
- i) Communications Skills
- j) Management of Aggression
- k) Adult Safeguarding
- I) Child Safeguarding

- m) Consent
- n) Confidentiality
- o) Risk Assessment and management
- p) Moving and Handling people

16.3 The Contractor's drivers of the non-emergency ambulances must hold a full and valid driving licence with the vehicle classifications required to drive the ambulance.

16.23 The Contractor, if providing non-emergency patient transport with a Healthcare Professional must provide as a minimum a qualified Paramedic or Nurse as part of the vehicle crew, who must be registered with the appropriate professional body and trained in Advanced Life Support (ALS).

I hope the above and attached fully assists you.
