Thank you for your request for information received on 28 March 2023 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below. The Trust would fully apologies for the delay in the provision of a response.

Question 1

I am looking to find out which of the Ambulance Trusts across the UK utilise mechanical cardiopulmonary resuscitation (mCPR) devices (such as the LUCAS or Zoll AutoPulse) and, if such devices are in use, when were they first introduced into service with the Northern Ireland Ambulance Service Trust.

Would you also be able to let me know which Emergency Medical Service personnel (e.g., Technicians, Paramedics, Advanced Paramedics, Senior Paramedics) are trained to utilise the mCPR device within their scope-of-practice?

It would also be very helpful for me to know how these devices are distributed across the service; for example, are mCPR devices standard equipment available on all Emergency Ambulances? or are they only carried on Rapid Response Vehicles with solo responders?

Answer 1

The Trust only have a LUCAS device at Helicopter Emergency Medical Service (HEMS). This has been there since its launch. Only HEMS clinicians are trained.

I hope the above fully assists you.
