There were 636 applicants for this recruitment exercise.

Applicants are expected to provide evidence to this effect during the pre-employment checks stage. Failure to do so results in a withdrawal of any conditional offer of employment. There were 201 applicants who were unsuccessful at interview and were not placed onto the waiting list.

Question 5

What steps are being taken to make sure that the selection and interviews process are done more fairly going forward?

Answer 5

The recruitment process was in accordance with the HSC Recruitment & Selection Framework and anti-discrimination legislation.
