## FREEDOM OF INFORMATION REQUEST

Thank you for your request for information received on 20 September 2023 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below.

## Question

1) Does your organisation use air-driven nebulisation? If so, is this routinely available on all emergency operations ambulances, or only on specialist resources (please expand on why if the latter)?

If the answer is 'No', please would you mind explaining why. Any reasoning is useful, whether its due to cost, training, space on ambulances, operating issues, or just because it hasn't been raised as an issue for consideration within your organisation etc.

If the answer is 'Yes':

- 2) What type/s of nebuliser do you use? Jet / ultrasonic wave / vibrating mesh / other
- 3) Are other products required to operate the nebuliser? Examples may include air cylinders, alternative preparations of respiratory medications, consumable parts such as air filters etc.
- 4) How are the nebulisers powered? Please provide information about battery charging, if applicable.
- 5) Are the nebulisers portable or connected to the ambulance?
- 6) Did your organisation measure any outcomes and/or gain any feedback when air-driven nebulisers were first introduced to the pre-hospital setting?
- 7) Are there any particular operational or clinician issues that have arisen from the use of air-driven nebulisers in your organisation?
