NHS111 Call Handlers who first answer NHS111 calls and are the first point of contact with yourselves following connection of a NHS111 call (Often but not exclusively called Health Advisors, Service Advisors, NHS111 call taker etc). If your trust does not operate an NHS111 service, please ignore this part of my request.


