Thank you for your request for information received on 5 October 2023 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below.

## Question

We would be interested to find out which anti-platelet treatments your service use in the pre-hospital setting in STEMI patients.

## **Answer**

The NIAS do not use anti-platelet treatment for STEMI care.
