Thank you for your request for information received on 6<sup>th</sup> February 2025 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below.

1. Can you provide me with a full and up to date fleet list including vehicle make/model, role and base station.	1. Please see attached document entitled '36196-25_FleetList'.
2. How many basics doctors do NIAS have access to deploy?	2. 6
3. Do NIAS have any plans to implement a MERIT resource to facilitate enhanced care at night?	3. NO
4. NIAS currently have an Advanced paramedic in critical care RRV, where is it based and are there any plans to expand the number of advanced paramedic RRVs to cover the whole region?	4. The Advanced Paramedic (Critical Care) RRV is currently co-located in Lisburn. It is a regional service and not confined to Lisburn/Greater Belfast. There are Trainee APCCs currently completing education which will allow for more consistent RRV cover and then scoping for expansion.
5. How many DCAs are deployed if a major incident is declared?	5. The number of doubled crewed ambulances attending a major incident is subject to information and intelligence available at the time of the incident.
