## FREEDOM OF INFORMATION REQUEST

Thank you for your request for information received on 3<sup>rd</sup> September 2025 which was dealt with under the terms of the Freedom of Information Act 2000. Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below.

## FOI QUESTION(S)

I would be grateful if you could provide me with the following data regarding Road Traffic Collisions (RTCs) involving a vehicle and a pedestrian for the last five years from the date of this request. The specific locations I am requesting data for are:

Knock Carriageway, Belfast Cregagh Road, Belfast

For each of these locations, please provide the following information:

The total number of RTCs where a vehicle collided with a pedestrian.

A breakdown of the injury types sustained by the pedestrians involved, categorised as follows:

Serious / life-changing injury

Minor injury

# ANSWER(S)

The total number of RTCs where a vehicle collided with a pedestrian at Knock Carriageway and Cregagh Road, Belfast in the last 5 years is <5.

Belfast Location	Category Injury	Number in last 5 years
Knock Carriageway	CAT 1	<5
Knock Carriageway	CAT 2	<5
Cregagh Road	CAT 2	<5

Regarding injury types NIAS can only provide data in the way it is held therefore the following call categories apply:

Category 1 (C1) – potentially life-threatening injuries and illnesses

Category 2 (C2) – serious but non-life-threatening emergency calls

Category 3 (C3) – urgent calls

There were no fatal calls.

The Trust has a duty to protect patient confidentiality, in line with this duty the figure <5 has been provided where the figures are very low. This is because of the potential risk of





identification of an individual. In reaching this decision the Trust has taken into account the small geographical area covered in this request. In addition the Trust has taken into account the fact that all information disclosed in response to an FOI is disclosed to the 'world at large' and will be published on the Trust website. I hope the above fully assists you.

Please note that, under the Re-use of Public Sector Information Regulations, if you wish to publish or otherwise use this information besides for your own means, you will need to seek our permission to do so.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter.
