Northern Ireland Ambulance Service (NIAS) Health and Social Care Trust has now completed its search for the information you requested and that is detailed below.

What is the full ranking structure that NIAS follow? (this relates to the whole of the organisation)	NIAS does not hold an overarching organisation chart, therefore, based on information currently available, please see attached the main directorate structures of NIAS. NIAS operates a ranked officer tier within its management structure. It serves to make those with authority easily identifiable to other Emergency Services and NIAS staff. It enables personnel to identify roles and responsibilities of the post holder in the event that staff may not recognise individuals.
What epaulettes does each rank wear?	Please see attached document entitled NIAS Epaulettes Visuals
What do the epaulettes' colours mean?	Green – Clinical Red – Critical care Specialist
